ENTRY FEE: \$180/Team
Entries are due no later than June 10th.

Format: Tournament will be a 2 day-2 person event. **Day 1** is Shamble. **Day 2** Best Ball for Championship flight and Shamble for all other flights. It will be flighted based on Saturday's scores.
**A free practice round is included on Friday.*

Procedure: **Shamble:** Both players tee off and select a tee shot. Play their own ball in from that position through the hole.

Tee Times: Players will be assigned tee times. Please select a time-slot you would prefer and the committee will do its best to accommodate.
